CONDITIONS OF CONSENT:

- a) All dogs must be registered.
- b) Dog faeces must be wrapped and disposed of to prevent the emission of any offensive odours. Faeces must be disposed of regularly and may be placed into a refuse bin.
- c) Food must be placed in clean food bowls for feeding. Any excess food or bones must not be left on the premises.
- d) Dog must not be permitted to wander at large.
- e) Kennels or hard surfaces must be easy to hose down and clean. This should be performed regularly to eliminate bad odours. Ideally, kennels should be connected to a sewerage system.
- f) Dogs shall not be permitted to bark so as to cause a nuisance to other people.

AUDITING:

The permit may be withdrawn or reviewed by Council should noncompliance of conditions occur. Council Officers reserve the right to inspect properties at any reasonable time.

APPEAL:

Council may, by notice in writing or otherwise, require the permit holder to take specific action within reasonable time frames as specified.

Failing to comply with a notice may result in the withdrawal; of the permit.

A person may appeal against a Council Decision. The appeal must be in writing and instituted within 14 days of Council's decision.
